CHAIRMAN'S MESSAGE





Dear Members,

Are you engaged in your profession with RPAC yet? Do you realize that we are the voice for homeowners private property rights and our industry? Do you know what bills are in front of our state government? Have you ever acted on your emails that ask you to respond to your local Legislative Representatives? If not, why?

Being a professional in any field brings the need to know about all facets of your business. The REALTORS® Political Action Committee (RPAC) was established to fight for our industry so you don't have to. RPAC works to promote homeownership and private property rights at the local, state, and national levels. You can sign up for RPAC <u>text alerts here</u>. Some of the current issues being worked on are:

Construction Defects Reform:

A big hurdle to building more entry-level housing is a defect in state law that exposes homebuilders and homeowners to a high risk of expensive, time-consuming litigation. It is referred to as the construction defects law. It has created a climate that puts the chill on new construction of affordable, multi-family housing, scaring off investment in the affordable-housing market.

Senate Bill 177, sponsored by Senators Scheffel & Ulibarri and Representatives DelGrosso & Singer, would begin to fix this problem and foster conditions that encourage builders to construct more affordable housing, provide increased homeownership opportunities for all Coloradans and stimulate our state's economy.

Changing Wildfire Tax Deduction to Tax Credit:

In 2013, the Governor convened his Wildfire Task Force to come up with proposals aimed at reducing wildfire damage throughout our state. While some of these proposals included mandating mitigation or creating a risk assessment program imposing fees based on wildfire risk – ideas that would be detrimental to real estate; the task force did recommend legislation that we believe provides an incentive for property owners to protect their property without being mandated to do so.

A similar bill died on the calendar last year, but Rep. Pete Lee and Sen. Ray Scott have introduced it again this session. This bill will change the Wildfire Tax Deduction to a tax credit, reducing dollar-for-dollar the amount of a person's tax liability.

The bill includes: A credit of 25% of the costs for mitigation; a maximum of \$2,500 credit; the credit can be carried over for 5 consecutive years.

These are just a sample of the many issues that are being worked on to help home ownership thrive. Both bills would have a local impact on us if passed. This does not happen by a computer generated event, it is the work of real people that have their feet on the ground for us and their voices where they can be heard. If you have not done so in 2016 please make a minimum donation to RPAC of \$25.00 towards supporting your voice in Real Estate. It does make a difference!

Aspen Traffic Congestion

At a recent City Council work session, council members gave city staff the go ahead to consider a couple projects this summer that would work towards accomplishing one of the city's stated goals of reducing auto traffic and congestion in the 16 square block downtown core.

The discussion will continue at the city council's scheduled February 23rd work session, but as of now Aspen is poised to try a few things:

- Dynamic pricing that changes for parking in the core.
 A four-month experiment will occur from May through August when parking stations will charge more in the high season than in the low season. This experiment is designed to discourage traffic congestion during the busiest parts of the summer. Staff will report back on the results of the experiment later this year.
- Staff was directed to send out an RFP for electric car transportation companies for the core area. Again, this one-year experiment will be to see if it impacts the way people get around the city core. Staff intends to select a company that uses a smart phone app for an "on demand" style of serving people from areas like the parking garage to restaurants and other destinations. The experiment will be sponsored by the city and will run at no charge to people who use the service.
- Though not decided yet, the city is considering closing off Galena Street to vehicle traffic roughly from Boogies to City Hall. The Mayor showed a lot of interest in seeing if this was feasible during peak hours of the high season. Again...this experiment has not received approval yet.
- Reinstituting the Aspen Community Forum from the 1990s.
 The Aspen Institute is interested in partnering with the
 city to host community forums that focus on walkability,
 congestion, and other quality of life issues. In my eyes, this is
 an opportunity for ABOR to host or partner with the city and
 the Institute on leading the discussion about what residents
 want from the city.

Impact on real estate – I'm interested in getting feedback from our membership about how these projects go this summer. Clearly, decreasing congestion is desirable from a "quality of life" perspective, but the solutions need to match and integrate with the character of the area. Let's monitor these projects closely this year and see how they turn out. Additionally, many REALTOR® work and park in the core area. Let's see how these initiative may (or may not) impact business.

ReThink The Streets Project Continues in Aspen

At a different city council work session, council members gave the go ahead to continue Aspen's creative "ReThink the Streets" project, but more work and council oversight is needed.

ReThink (**Click here**) is Aspen's version of placemaking, where towns and cities consider city streets as places to not necessarily travel "on" or "through" but places to "be". City staff was instructed to learn from last summer's positives and negatives from the project and come back to council later this year for direction on how to proceed, what to do, whom to use as a consultant, etc.

The National Association of REALTORS® has significant resources available for boards such as ABOR to use in shaping projects like this. REALTORS® are significant stakeholders in the future use and design of our future and can add real value to any discussion such as this. I've been in contact with the city staff managing the project to let them know ABOR would have interest in this issue. Stay tuned for further developments once city staff has more ready to present to city council.

Reauthorization of Open Space Property Tax may appear on Pitkin County Ballot in November

Pitkin County commissioners were generally supportive Tuesday of plans by the Open Space and Trails Board to ask voters in November to reauthorize a property tax that supports the program.

"I think the public looks on Open Space and Trails as one of the premier programs in town," Commissioner Michael Owsley said. "It's an extraordinary thing."

Owsley, along with commissioners George Newman and Patti Clapper, all said they'd support asking voters to reapprove the current levy in November. That 3.75 levy expires in 2020 and generated a little more than \$11 million in 2015, said Pitkin County Manager Jon Peacock.

ABOR will continue to monitor this issue. It seems as if the public is generally supportive of the way this tax is used, but it remains to be seen if there is an appetite for permanently making the mil part of the tax code or if it needs periodic review.




