Aspen Sign Code Update

At the July 10th City Council meeting, the City Council will consider a Policy Resolution to amend the sign code. The public is encouraged to visit http://www.aspencommunityvoice.com/sign-code-update to take a survey and participate in the sign code update process before Council considers an ordinance to amend the code at the July 24th Council meeting. The survey results will have a direct impact on the potential amendment to the sign code. You may also contact Phillip Supino in the Planning Department for more information at phillip.supino@cityofaspen.com

Due to a 2015 Supreme Court decision, the City of Aspen is in the process of updating its commercial and residential sign code. The court ruling stipulates that municipal sign regulations must be content neutral, which means: "if you have to read the sign to know whether it is allowed, then it is not content neutral."

These changes may impact everything from menu boxes and sandwich boards to construction site and real estate listing signs. Please take the time to provide input if you have a sign for your business or care about signage in Aspen

Downtown Pedestrian Mall Discussion Progressing

Near the end of June, I participated in a Placemaking workshop for Aspen's downtown pedestrian mall. The purpose of the workshop was to continue to gather public opinion on the look and makeup of the mall in the near future. The infrastructure underneath the mall is deteriorating and the city will be pulling up the bricks sometime in the next few years. Fortunately, they are engaging the public right now to determine what the mall should look like when the mall goes back down.

Placemaking is a Smart Growth term defined as the act of people collectively and deliberately shaping their public spaces to facilitate social interactions and improve their community's quality of life. The National Association of REALTORS® has grant money and program assistance available to local associations such as ours to engage in local projects and make a piece of that project our own.

Since quality of life is something so heartily embraced by residents of Aspen and the surrounding area, it is important to voice your opinion on what the future of our public spaces should look like. If you have specific ideas on the future of the pedestrian mall or the role of the Aspen Board of REALTORS® should take in the shaping of the mall, please let the ABR Board of Directors or me know. NAR Submits Statement on Housing Finance Reform

On June 29, 2017, the U.S. Senate Committee on Banking, Housing & Urban Affairs held its first of several hearings of the year on housing finance reform. The hearing, entitled "Principles of Housing Finance Reform" consisted of three witness panelists from the Mortgage Bankers Association, Housing Policy Counsel of the Financial Services Roundtable, and Center for Responsible Lending.

NAR submitted a statement highlighting that any new housing finance system must ensure that in all markets mortgage capital will always remain available for creditworthy Americans. Second, NAR stated that taxpayer dollars should be protected.

In order to shield taxpayers and ensure a steady flow of capital into the mortgage market in both good times and bad, NAR urged lawmakers to convert the Enterprises into government-chartered, non-shareholder owned authorities that are subject to tighter regulations on products, profitability, and minimal retained portfolio practices in a way that ensures the protection of taxpayer monies.

NAR Joins Coalition to Preserve Net Neutrality

NAR has joined a coalition of businesses and public interest groups working to preserve Open Internet rules—also known as network neutrality. NAR together with tech companies like Facebook, Microsoft and Amazon and main street companies like Walmart have joined together to advocate for preserving net neutrality. The coalition will work at the Federal Communications Commission (FCC), in the courts and on Capitol Hill to ensure that internet remains an open and level playing field, an issue critical to our business success.

Net neutrality is shorthand for the concept that Internet users should be in control of what content they view and what applications they use on the Internet. More specifically, net neutrality requires that broadband networks be free of restrictions on content, sites, or platforms. Networks should not restrict the equipment that may be attached to them, nor the modes of communication allowed on them. Finally, networks should ensure that communication is not unreasonably degraded by other communication streams.

Net neutrality is important to small, main street businesses like REALTORS® who depend on open internet access every day to run their businesses and serve their customers.

NAR supports net neutrality and urges Congress to oppose legislation that would threaten the current FCC Open Internet Rule and rollback the important protections put in place by the FCC in 2015.

FIRE RESTRICTIONS IN EFFECT IN PITKIN COUNTY

Effective July 1, 2017, due to increasing fire danger, Pitkin County has imposed a Stage I fire restriction, aimed at preventing the start of wildfires based on human activities that are known to be high risk, specifically smoking and campfires.

PROHIBITED UNDER A STAGE I RESTRICTION -

- FIRES OR CAMPFIRES except within a developed recreation site or established fire ring
- SMOKING except within an enclosed vehicle, building, or developed recreation site
- OPERATING ANY COMBUSTION ENGINE without a properly installed spark-arresting device
- FIREWORKS OF ANY KIND except professional, permitted shows

VIOLATIONS OF THESE REGULATIONS IS PUNISHABLE BY A FINE OF UP TO \$5000 OR IMPRISONMENT FOR UP TO 6 MONTHS OR BOTH.

Your Pitkin County Sheriff and your local fire protection districts urge you to do your part to prevent human-caused wildfire and to keep your home, family and community safe.




