I consent and authorize the Board, through its Membership committee or otherwise, to invite and receive information and/ or comments about me from any Member or other person, and I further agree that any information and comments furnished to the Board by any person in response to any such invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.
